

**“WIN A LE CREUSET SIGNATURE CAST IRON ROUND CASSEROLE & 1 YEAR  
SUPPLY OF BONNE MAMAN CONSERVE” PROMOTION**

**TERMS AND CONDITIONS**

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Australian residents aged 18 years or over.
3. Employees (and their immediate families) of the Promoter, Participating Retailers (as defined below) and agencies associated with this promotion are ineligible to enter.
